THE SOLUTION (I)

DECLARATION OF OMISSION

I, the undersigned, Mr. zhisibeng Hu, acting on behalf of SHANGHAI RONGTAI FITNESS TECH. DEVELOPMENT CO., LTD, NO.1226 Shufeng Road, Qisggu District, Shanghai, China, declare the following:



1. To immediately stop any use whatsoever (amongst others manufacturing, sale and distribution) of products using copies of the registered design of Eurokeyton, such as protected by the registration file No. ZL 02302052.0; especially to stop any use of the model RT-Y021 Western Massage Chair.

2. Not to repeat any actions in the future, which violate Eurokeyton's intellectual property rights.

3. For any case of breach of such obligation as mentioned under 1. and 2., SHANGHAI RONGTAI FITNESS TECH. DEVELOPMENT CO.,LTD will pay an adequate penalty, which shall be determined by Eurokeyton, whereby SHANGHAI RONGTAI FITNESS TECH. DEVELOPMENT CO.,LTD, renounces on the objection of a continued action. Eurokeyton shall be entitled to demand any damages exceeding such penalty, being understood that any paid penalty will be compensated with such exceeding damages

4. Take out of Rongtai's catalogues, model RT-Y021 and any other similar models whose property rights belong to Eurokeyton. Send to Spanish Commercial Office before 1.1.2005 2 Rongtai catalogues in which model RT-Y021 is no longer offered to sale.

5. Spanish law shall be applicable to the present declaration.
